TERMS OF AGREEMENT

LIVE, CIGAR ROLLING Upon request, the Client will be supplied with a cigar roller who will roll cigars during the time between the "Start Time" and "End Time" at the location address on the date specified above. The cigar roller will provide some pre-rolled cigars along with the cigars that will be created at the event. The total quantity and type of cigars are stated above.

CIGAR SERVER Upon request, the Client will be supplied with a cigar server who will serve guests of the event during the time between the "Start Time" and "End Time" on the date specified above. The cigar server will walk throughout the area of the event with a specially designed tray to serve the guest's cigars.

CUSTOM CIGAR BANDS Upon request, the entire quantity of cigars requested by the Client will have Custom Designed Cigar Bands attached. The designs for the Custom Bands have been approved by the Client before the event date.

DISPLAY HUMIDOR/CIGAR TRAY Upon request, the Client will be supplied with a display humidor which can also be converted to a cigar tray. The humidor or tray will be shipped to the Client and arrive before the event date. If requested, a deposit of \$200 is accepted by the Vendor and will be returned to the Client after the humidor or tray is returned with absolutely no damage and found to be fully functional by the Vendor.

Client agrees to have the cost for this agreement paid in full no later than 28 days prior to the event date. Client agrees that the terms and conditions of this agreement shall be interpreted under the laws of the State of New York.
